




## ENTREPRENEURSHIP AND TRANSFORMER PROGRAM

Our three semester academic calendar with start dates in January, May and September means you can graduate sooner and achieve your goals faster.


## ACCELERATED PROGRAMS


In addition to fast-tracked programs, Bond offers a range of 2 year 'Professional' master's programs for international students interested in applying for a Post Study Work visa.



## BOND UNIVERSITY STUDENT ASSOCIATION (BUSA)

Student activities are organised under the umbrella of BUSA which also serves as the student representative body on academic and administrative issues.

All students pay a Student Activities Membership (SAM) fee each semester which covers the cost of their membership to all University clubs and societies, and access to all facilities and classes at the Bond University Sports Centre.



## RELIGION

# SPORT IS IN OUR DNA

Sport and education are entwined at Bond University. We have a proud sporting tradition and we provide opportunities for students to participate at a social, competitive or professional level.

## BOND UNIVERSITY SPORTS CENTRE

The University's multi-million dollar Sports Centre incorporates a state-of-the-art gymnasium, TRX Suspension Training Studio, boxing circuit training room, and a regular timetable of group exercise classes. Bond's Aquatic Centre includes a 50m Olympic-size heated swimming pool and a FINA-rated 10-lane, 25m pool. The campus also features extensive outdoor sporting facilities for rugby, AFL, cricket and tennis as well as indoor basketball, netball, esports, futsal, badminton, volleyball, cricket nets and squash courts.

## SPORT CLUBS

Joining a sporting club is a great way to meet new friends and Bond has more than 20 to choose from. Competing under the Bond Bull Sharks banner you'll have the opportunity to compete in the Australian University Nationals.

## HIGH PERFORMANCE SPORTS

Bond has key performance sports including swimming, rugby, rugby sevens (men and women), AFL (men and women), triathlon, netball, equestrian and esports offering world-class coaching, facilities and partnerships to ensure we compete at the highest level both domestically and internationally. Olympic and international athletes of distinction populate the sports in these programs.

## ESPORTS

A recent addition to Bond's high performance sports facilities is the state-of-the-art Esports Hub. Devoted to competitive video-gaming, the Esports Hub is equipped with 12 high-performance gaming machines, a training and coaching facility for analysis and strategy and the ability to stream to Bond's 500-seat theatre for an audience.

## ELITE SPORT PROGRAM

Bond University is a member of the Australian Sport Commission's Elite Athlete Education Network (EAEN), which provides flexible study loads and requirements for athletes at the very top of their sport. Athletes competing at a state, national or international level in their chosen sport are invited to apply to the Bond Elite Sport Program.

## SPORTS RESEARCH

The Bond Institute of Health & Sport is a world-class teaching and training centre which regularly hosts international athletes and professional teams. Specialist training and preparation facilities of the Institute's High Performance Training Centre include a 25m indoor lap pool, temperature controlled recovery pools, oxygen-regulated altitude training room and the sports science laboratories. The Institute is also used extensively by students studying exercise and sports science, physiotherapy and occupational therapy.

## GETTING AROUND THE GOLD COAST



**By train** - A rail service operates from Robina or Varsity Lakes station close to Bond University, to the Brisbane CBD, Brisbane Airports and other Gold Coast destinations.



**By bus** - Regular bus services operate from in front of the University to the main shopping, residential and tourist areas on the Gold Coast.



**Walking distance from campus** - there are shops, a small supermarket, cafes, restaurants and facilities just outside the campus at Varsity Lakes.

# ACCOMMODATION

Bond is located in a landscaped residential neighbourhood with a wide range of on-campus and off-campus accommodation available for our students within easy walking distance of all University study and recreational facilities.

## ON-CAMPUS

On-campus housing offers your choice of air-conditioned single or shared rooms. Residents benefit from one-on-one academic and personal support from the live-in team of Senior Resident Fellows, Resident Student Fellows and Tutor Fellows.

## MEAL PLANS

For students living on campus, it is compulsory to have a dining plan. These flexible prepaid plans can be used to purchase meals on campus at Lakeside Bar and Restaurant, Papyrus Café, Don's Tavern, Coffee Cart at Palm Court, Bond Express, Pulse Café and the University Club.

## UNDERGRADUATE PROGRAMS

### BACHELOR'S DEGREE

Admission to a bachelor's degree is usually based on high school academic results and English language criteria.

## POSTGRADUATE PROGRAMS

Admission to postgraduate coursework degrees generally requires a bachelor's degree from a recognised university, however in some cases, extensive career experience in a relevant industry may meet the entry criteria.

Bond also offers 'Professional' master's programs for students in a range of different study areas, where you can incorporate a 20-week work integrated learning semester to complement your postgraduate program. This extensive industry experience will improve your knowledge, skills and employability, helping you stand out to future employers.

## HIGHER DEGREES BY RESEARCH (HDR)

Admission to HDR programs generally requires a bachelor's degree with Class I or Class II Honours, a postgraduate qualification incorporating a significant research component, or a record of significant research experience deemed to be of a comparable standard to a bachelor's degree with Class I or Class II Honours. 
## GRADUATE SOONER WITH OUR THREE SEMESTER SYSTEM

Bond's teaching calendar is based on three semesters per year, rather than the usual two. Our programs start earlier in the year, with shorter breaks between each semester so you can graduate much sooner. You could also complete a combined degree or an undergraduate and postgraduate degree in less time than it would take to complete a single degree at another university.

Our semester start dates are in January, May and September to give you more flexibility about when you start your degree.





Replicating a hospital ward, the Bond Virtual Hospital is the first of its kind and offers clinical teaching sessions with simulated patients, allowing students to learn vital skills in a real life setting.



## RESEARCH INTENSIVE

The Faculty houses the Institute for Evidence-Based Healthcare, Clem Jones Research Centre for Regenerative Medicine, the Centre for Urology Research and the Clinical Education and Research Centre (a collaboration with Queensland Health).



## CLINICAL SKILLS ROOMS

Bond University has state-of-the-art clinical skills rooms with purpose-built clinical facilities that reflect what is currently being used in clinical practice. They provide practical experience for students studying medicine, nutrition and dietetics, and physiotherapy. The largest clinical skills room is designed to simulate a hospital setting where students learn by computerised simulation, through patient actors and human patient simulators (fully interactive mannequins).



## TEACHING AND RESEARCH LABORATORIES

Bond University has 13 teaching laboratories, including the multimedia labs with 25 computers per room. The laboratory facilities are well equipped for studying diverse areas of science, including pharmacology, physiology, chemistry, microbiology, molecular biology and genetics. Most teaching labs are open and available to students 24 hours per day, even outside of class hours. The Faculty of Health Sciences & Medicine also houses research units such as the Institute for Evidence-Based Healthcare, Clem Jones Research Centre for Regenerative Medicine, the Centre for Urology Research and the Clinical Education Research Centre - a collaboration with Queensland Health.






